The Company filed its Form 10-Q for the period ended March 31, 2011 on May 17, 2011. The Company reported revenues of \$10.7 million for the quarter ended March 31, 2011, compared to \$8.4 million for same period in 2010, an increase of approximately 28%. The Company's gross profit increased by \$1.1 million during the quarter ended March 31, 2011 compared to the quarter ended March 31, 2010. Net income increased to \$812,000 during the quarter ended March 31, 2011 compared to net income of \$217,000 during the quarter ended March 31, 2010. The increase in revenues and profits were the result of overall increase in demand for major product categories in all major geographic regions.
